
Cadbury Plc | Equities | 2021 Q1 | Earnings Update 28th April 2021



CADBURY Plc recorded a 62.19 percent drop in profitability posts N241.54 Mn profit after tax as increased cost of raw materials impact profitability negatively, with the company growing cost of sales faster than revenue. Revenue in 2020 Q1 stood at N8.55 Bn compared to N8.92 Bn in Q1 2021 while cost of sales stood at N6.26 in 2020 Q1 as against N7.43 Bn in 2021 Q1, both revenue and cost of sales grew by 4.29 percent and 18.62 percent respectively.

Meanwhile, the breverage king recorded a significant dip in return on asset and return on equity, return on asset moved from 7.94 percent in 2020 Q1 to 2.61 percent in 2021 Q1 while, return on equity moved to 7.01 percent in 2021 Q1 from 17.99 percent in 2020 Q1. CADBURY Plc grew more cost inefficient as the company's cost to income ratio moved from 64.83 percent in 2020 Q1 to 78.35 percent in 2021 Q1.

However, as COVID-19 vaccination gains traction in Nigeria the economy is expected to continue to recover and beverage sales is expected to see an uptrend. As inflation continues to creep upwards, cost of production might also continue to go up if the monetary authorities don't act to curb inflation.
