


## SEPLAT return to profitability records 20.47% growth in net profit margin.

After a difficult 2020 for the oil industry owing to the global Covid-19 pandemic, SEPLAT has recovered nicely by improving profitability as revenue topped the N120Bn mark. The oil giant recorded a Profit-After-Tax of N14.11 bn from a loss of N37 Bn in H1-2020 after growing revenue by 50.36% to N120.44 Bn in H1-2021


Meanwhile, the company's impressive performance can be attributed to revenue growth and reduced operating cost, as proceeds from gas operations accounted for 98% of the oil company's profits, which is N13.02 Bn. While operating expenses declined by 75.34%, from N71.52 Bn in 2020 H1 to N17.63 Bn in 2021 H1.


SEPLAT returned to delivering returns to investors giving them little to cheer about after it recorded a 2.08% return on equity in 2021 H1, better than the 6.27% investors lost on their investment in 2020 H1. The oil company grew assets to N1.41 Tr in 2021 H1 from N1.09 Tr in 2020 H1 and borrowings, slightly by 7.34%.

However, as oil prices continue to soar currently above the \$70 per barrel mark amid improved demand and oil production cuts, we expect a potential upside of 11.69% as oil demand continues to improve globally, owing to increasing covid-19 inoculations and economic activities both locally and internationally.
