Equity Market Slips by 0.25% Amid Sell-Offs in Blue-Chip Stocks

Local bourse closed trading session for today in red, with key performance indicators, the NGX-ASI and Market Capitalization, both receding by 0.25%. The market index (All-Share Index) reduced by 244.73 basis points in today's trading session, reflecting a 0.25% decrease to close at 97,233.07. Similarly, the Market Capitalization also lost ¥148.16 billion, representing a decline of 0.25%, settling at ¥58.92 trillion. Although market breadth ended largely positive, the market's overall decline was driven by sell-offs in blue-chip stocks such as CONOIL, BUACEMENT, and others, leading to a ¥148 billion reduction in investors' wealth.

However, market activities were up, as the Total Volume and Total Value traded for today increased by 18.02% and 4.08% respectively. Approximately 291.53 million units valued at #7,816.90 million were transacted across 7,931 deals. ACCESSCORP was the most traded stock in terms of volume, accounting for 20.78% of the total volume of trades, followed by UBA (6.17%), ZENITHBANK (5.59%), OANDO (5.38%), and UCAP (5.31%) to complete the top 5 on the volume chart. ACCESSCORP also emerged as the most traded stock in value terms, with 19.32% of the total value of trades on the exchange.

FLOURMILL and TIP topped the advancers' chart for today with a price appreciation of 10.00 percent each, trailed by JOHNHOLT with (+9.86%) growth, INTENEGINS (+9.85%), SUNUASSUR (+9.75%), CONHALLPLC (+9.62%), TANTALIZER (+9.52%) and twenty-five others. Fifteen (15) stocks depreciated, where ABBEYBDS was the top loser, with a price depreciation of -9.77%, as CONOIL (-6.15%), BUACEMENT (-5.93%), CUSTODIAN (-4.76%), ELLAHLAKES (-4.11%), and OANDO (-3.23%) also dipped in price. In that regard, the market breadth closed positive, recording 32 gainers and 15 losers.

Additionally, the market sector performance was positive, as three of the five major market sectors were up, led by the insurance sector which grew by (0.95%), followed by the Consumer goods sector by (0.56%), and the Banking sector by (0.53%), while the Industrial and Oil & Gas sectors were down by -1.85% and -1.76% accordingly.

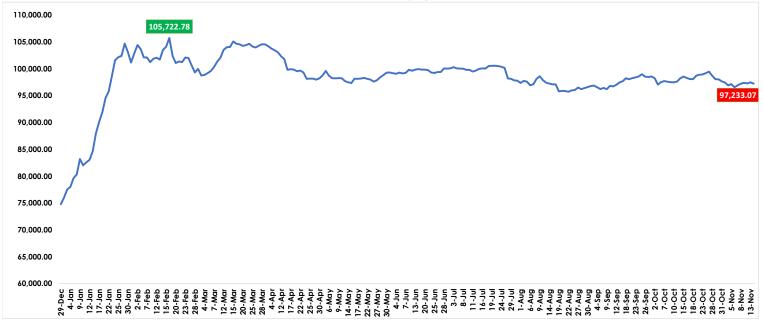
